A RESOLUTION LEVYING GENERAL PROPERTY TAXES  
FOR THE TAXABLE YEAR 2015  
TO HELP DEFRAY THE COST OF GOVERNMENT  
FOR THE TOWN OF PAONIA, COLORADO  
FOR THE 2016 BUDGET AND FISCAL YEAR

WHEREAS, the amount of funds necessary to balance the budget for general operating purposes from projected property tax revenues for the 2016 Budget and Fiscal Year is \$103,243; and

WHEREAS, the 2015 Total Assessed Valuation for the Town of Paonia, Colorado as certified by the Delta County Assessor is \$12,320,386; and


NOW, THEREFORE, be it resolved by the Town Board of Trustees of the Town of Paonia, Colorado;


That for the purpose of meeting all general operating expenses of the Town of Paonia, Colorado during the 2016 Town Budget and Fiscal Year, there is hereby levied a tax of 8.322 mills upon each dollar of the Total Assessed Valuation for all taxable property within the Town for Taxable Year 2015; and


